# Tribal Sexual Assault Services Programs (TSASP) Annual Training Institute

This year's Institute will have two parts:

### **November 2-3, 2020: *Sex Trafficking in Indian Country Training***

- This training is **for** TSASP grantees that have included the sex trafficking priority as part of their grant project, and is optional for all other TSASP grantees. Space is limited to 30 participants. Priority will be given to those working directly with sex trafficking victims. Participants will receive a Certificate of Completion for units 1-4 from the Tribal Law & Policy Institute.

### **November 4, 2020: *TSASP Training***

- This day of training is required for all TSASP grantees.
- Through this required virtual event, MIWSAC will bring TSASP grantees together that are committed to eliminating sexual assault, stalking, and sex trafficking of American Indian and Alaska Native adults and youth. Workshops will offer discipline specific foundational-level understanding of sexual assault & sex trafficking of Native victims. Sessions will focus on strategies to support American Indian and Alaska Native survivors while holding offenders accountable.
